

CYBERJUMP BUDA TRAMPOLINE PARK X LASERPARK BUDAPEST GIVEAWAY OFFICIAL TERMS AND CONDITIONS OF PARTICIPATION AND RULES

1. Organizer of the Giveaway

1.1. The organizer of the giveaway (hereinafter: the “Giveaway”) presented in these terms and conditions of participation and rules (hereinafter: the “Rules”) is **(registered office: 2085 Pilisvörösvár, Szent Erzsébet utca 45.; company registration number: 13 09 130348; tax number: 14848285-2-13; hereinafter: the “Organizer”).** (registered office: 2085 Pilisvörösvár, Szent Erzsébet utca 45.; company registration number: 13 09 130348; tax number: 14848285-2-13; hereinafter: the “Organizer”).

1.2. The Organizer carries out the data processing and data management related to the Giveaway (hereinafter: the “Data Controller”).

2. Conditions for Participation in the Giveaway

2.1. Any natural person who has reached the age of 18 (hereinafter: the “Participant”), has a valid Facebook account, and fulfills the participation requirements set out in these Rules during the term of the Giveaway may participate in the Giveaway.

2.2. The owners and employees of the Organizer and their close relatives, as well as any other persons directly involved in the organization and administration of the Giveaway, may not participate in the Giveaway.

2.3. Participation in the Giveaway is subject to the Participant:

- following the Laserpark Budapest Facebook page;
- following the Cyberjump Buda Trampoline Park Facebook page;
- liking the post announcing the Giveaway;
- and commenting under 3-3, i.e. a total of 6 Facebook posts of these pages,

The participation shall be valid only if the Participant fulfills the commenting requirement under all six Facebook posts during the term of the Giveaway.

2.4. By participating in the Giveaway, the Participant acknowledges that they have fully read and understood these Rules and unconditionally accept their provisions.

2.5. Participation in the Giveaway is not subject to any purchase or other consideration.

3. Administration of the Giveaway

3.1. Duration of the Giveaway:

Start date of the Giveaway: **September 15, 2026.**

End date of the Giveaway: **October 5, 2026.**

Start date of the drawing and notification of the Winners: **October 5, 2026.**

3.2. How to Participate

To participate in the Cyberjump Buda Trampoline Park X Laserpark Budapest Giveaway announced on September 15, 2026, the Participant must fulfill all participation requirements set out in Section 2.3 of these Rules during the term of the Giveaway.

Only Participants who have fulfilled the specified participation requirements by the end of the Giveaway shall be eligible to participate in the Giveaway.

3.3. Prize of the Giveaway

A total of 6 (six) winners will be selected in the Giveaway.

The prizes are as follows:

- **3 Laserpark vouchers for 10 people, valid for 1 hour, which may be used within 1 year from the date of issue;**
- **3 Cyberjump Buda Trampoline Park gift packages, which, among other things, contain a voucher entitling 2 people to 2 hours of jumping.**

Each Winner is entitled to one prize.

The prize cannot be redeemed for cash, exchanged for another prize, or transferred to another person.

3.4. Drawing Procedure

The Organizer will select a total of 6 (six) Winners by drawing from among the Participants who meet the participation requirements set out in these Rules.

The drawing will be conducted randomly among the Participants who have validly participated during the term of the Giveaway.

During the drawing, the Organizer is entitled to verify whether the selected Participant has fulfilled all participation requirements. If the selected person does not meet the conditions set out in these Rules, the Organizer is entitled to disqualify that person and draw a new Winner in their place.

3.5. Notification of Winners

The Organizer will notify the Winners by Facebook message within 1 business day following the end of the Giveaway.

In the notification, the Organizer will inform the Winners of the further steps required to receive the prize, as well as the contact details necessary for this purpose, in particular the provision of an e-mail address.

3.6. Receipt of the Prize

The Winners may collect the prize at the Cyberjump reception.

The prize may be collected within 6 weeks from the notification of the Winner.

If the Winner does not respond to the Facebook message, fails to provide the information required to receive the prize, or does not collect the prize within the specified 6-week period, the Organizer is entitled to draw a substitute winner.

4. Rights and Liability of the Organizer

4.1. By participating in the Giveaway, the Participant accepts that they shall be fully liable for any damage caused to the Organizer by any breach of these Rules during participation.

4.2. In the event of a breach of these Rules, the Organizer shall disqualify the Participant from the Giveaway. If a disqualified Participant is selected in the drawing, the Organizer is entitled to draw a new Winner in their place.

4.3. The Organizer excludes liability for any damage suffered by the Participant or any third party arising from the Participant's incorrect, inaccurate, or incomplete provision of data, or from the loss, unsuccessful delivery for any reason not attributable to the Organizer, or delay of the notification sent electronically to the Winner.

4.4. The Organizer reserves the right to modify, suspend, or terminate the Giveaway in the event of unforeseen circumstances. The Participants will be informed of this on the communication channels of the Giveaway.

4.5. The Giveaway is not sponsored, endorsed, administered by, or associated with Facebook. The Giveaway is organized exclusively by the Organizer.

5. Data Management

5.1. The Organizer processes the personal data of the Participants in accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council (GDPR), Act CXII of 2011 on Informational Self-Determination and Freedom of Information, and other applicable laws and regulations.

5.2. The detailed rules governing the processing of data related to the Giveaway are set out in the Organizer's Privacy Notice.

5.3. The processing of personal data necessary for the administration of the Giveaway shall take place to the extent and for the period necessary for the administration of the Giveaway, the identification and notification of the Winners, and the delivery of the prizes.

6. Data Controller, Data Processor

6.1. The Data Controller shall not transfer the data to any third party, except where such transfer is required by law or takes place for a lawful purpose specified in the Privacy Notice.

6.2. The Data Controller processes only those personal data of the Participant that the Participant voluntarily provides when participating in the Giveaway or collecting the prize.

6.3. The Data Controller processes the Participant's personal data for the purpose of participation in the Giveaway, notification of the Winners, and administration of the delivery of the prizes.

6.4. The Data Controller processes the Participant's personal data for the period necessary for the administration of the Giveaway, including the delivery of the prizes, as specified in the Privacy Notice.

6.5. The Participant may exercise their rights relating to data processing in the manner and through the contact details specified in the Privacy Notice.

6.6. The Data Controller ensures the security of the Participant's personal data and implements the technical and organizational measures necessary to guarantee an appropriate level of protection of the Participant's personal data.

7. Complaints and Claims

7.1. In the event of a data protection complaint, the Participant may contact the Hungarian National Authority for Data Protection and Freedom of Information or the competent court.

7.3. The Organizer shall investigate the complaint received and respond to it within the time limit prescribed by the applicable laws and regulations.

7.4. In the event of a complaint or claim, the Organizer is entitled to process the personal data provided by the complainant in the complaint for the period necessary to investigate and handle the complaint.

The administration of the Giveaway and participation therein shall be governed by these Rules, the Organizer's General Terms and Conditions and Privacy Notice, as well as the provisions of applicable laws and regulations.

If these Rules do not regulate a particular matter, the relevant provisions of the applicable laws and regulations shall apply.
